Entry Limit: This test is limited to 20 Newfoundlands. Entries over this limit will be placed on an alternate list. Openings will be filled from the alternate list in the order received. Re-qualifiers will be accepted as space allows and will be judged last in their class. In other words, untitled dogs will be given priority even if their entry is received after that of a titled dog.

Entry Fee: \$40.00, payable to NCSD, or Newfoundland Club of San Diego.

Dates: Open date for entries is August 23, 2010. Postmarks before this date will be returned Closing date for entries is September 16, 2010.

Water test regulations: All entrants are responsible for reading and understanding the NCA Water Test rules and regulations.

Description of site: Glorietta Bay is a salt-water site. There is ample green grass and trees for shade. If you have a tent or shade, it is a good idea to bring it. The beach is clean and the water is typically very clear. There is a moderately quick drop off. Most dogs will be swimming within 10 feet.

Pre-test practice: The site will be available for informal practice on Saturday September 25, 2010 from 10:00 am to 2:00pm.

Parking at Test Site: Ample parking is usually available. There is no fee to park.

Miscellaneous: Bitches in season will be allowed to participate, but will be judged after all other entries have completed the entire test.
